

Empower Your Patients

Prescription counseling is not a requirement for the utilization of MAT products. However, please educate patients on MAT products before prescribing. Make referrals when needed and encourage patients to seek counseling as necessary.

No Prior Authorization Required

- Suboxone® (buprenorphine/naloxone SL films), brand preferred
- Buprenorphine/naloxone SL tablets, generic only
- Vivitrol® (naltrexone injection)

Naloxone Companion Prescription

Naloxone, the opioid overdose antidote, should be prescribed with all MAT prescriptions. Providers are encouraged to co-prescribe this life-saving drug to all at-risk patients.

E-Prescribing

OHCA encourages providers to utilize electronic prescribing of controlled substance (EPCS) to assist in the reduction of diversion, fraud and abuse. EPCS of CII and CIII-V is permitted by Oklahoma state law.

Benefits of EPCS

- Potential to reduce Rx drug abuse
- Secure, tamper-proof transactions (eliminates paper and forgery)
- Reduction in diversion and fraud by “secure” transactions

Check the PMP Every Time

The Prescription Monitoring Program (PMP) is a proactive tool that assists medical professionals in making informed decisions about a patient’s prior drug use history. The PMP ensures continuity across all levels of care providers including physicians, pharmacies and law enforcement agencies while helping to prevent prescription drug abuse and fraud.
